Regional Development Concept of Angkor Chum District

1. Introduction

In August 2008 District Core Group (DCG) organized a first workshop on Regional Management (RM) with the participants of all district stakeholders from public (e.g. commune and district authority, district offices), private (e.g. farmer, vendor, collector, rice miller...) sectors and civil society (e.g. association, community, and groups). RM is referred to the voluntary participation of the stakeholders from all sectors to collectively foster local economic development. With this regard, we organized various activities that support the increase of the people's income for instances technical trainings on rice and animal productions for the farmers, agreement between rice seller and buyer, right weight use, re-activating farmer's group and creating new groups (producer groups). Those volunteer stakeholders proposed different project ideas, which they are the implementers, in order to provide the benefits for their selves, community and the district as a whole. All project ideas are compiled into a document named "Regional Development Concept of Angkor Chum District". This document serves as a common direction of the district stakeholders in local economic development, which complements the district development plan and draws attention of the insiders and outsiders so that they are informed about the local economic development activities and involved.

Since 2011 till 2014, it has been 4 years that Angkor Chum RDC paper has been developed. Organization to Promote Economic Development in Angkor Chum (**OPED Angkor Chum**) was established to facilitate the proposed projects in this concept paper. Most of the projects have been actively implemented and successful with technical support from **OPED Angkor Chum** in cooperation with rice millers, CEDAC and input (animal feed) supply companies, such as BKP, Lyhong Chory, VPAVET and MEdivET, and financial and technical supports from Reginal Economic Development Program (RED III). In parallel, some project initiators stopped their projects which have had no activities at all. In 2015, we update the paper by eliminating the unworkable projects and add new ones raised by the active project initiators.

2. Angkor Chum's Strengths

- High volume of paddy production, leading to every year export to other districts
- 3 big rice millers
- The field of cassava, fruit and bamboo productions (in Kouk Doung, Srae Khvav, and Doun Peng communes)
- The availability of river water sources and dam for various use
- Transportation roads, crossing all communes and connecting to different districts such as Kralanh, Puok, Angkor Thom, Varin and Srei Snorm
- 5 community forests with some 705 hectares of land
- Human resource and raw materials (e.g. the craftmakers are skillful in rattan, some farmers has good techniques in production...)
- At the village-and-commune level, there are many big ponds attracting natural fish and for fish production
- Slaughterhouse, cow production (Srae Khva commune) and pig (many heads) production per family (Kouk Doung and Cha Chhouk communes)
- Financial services provided by a bank's service post and other 7 MFIs

3. Challenges

- Less number of rice seed producer group that the production does not meet the demand of farmers inside and outside the district
- The limitation of production know-how and group management
Most people have only one income source
- People focus only on single income source
- The cooperation between producers/raisers to create group or network to share experience, market information and collectively sell the products is still limited
- Animal diseases outbreaks often
- The price of products and collection of middle person/processor is stable, making difficulties for the producers
- Lack of investment in processing locally

4. Vision

The living condition of Angkor Chum's people will be improved with sustainability, welfare, income growth based on the enhancement of paddy rice quality for exportation and diversification of income-generating sources through utilizing existing resources of the district.

Slogan "Angkor Chum mobilizable, prospering economy"

- Improve production quality and quantity
- Diversify people's income sources

Project Description

Nowadays, rice seed producer groups in our district are producing pure rice seed in a certain quantity and selling to local farmers and the farmers in other districts. As more and more farmers are aware of benefits of pure rice seed use that are increasing yield and price, we proposed this project in order to build technical capacity to the existing group members so that the quality of rice seed is assured and the supply quantity will be enlarged via expanding the production plots and involving more group members in seed production. Additionally, we promote our rice seed to the farmers inside and outside the district, who produce commercial quality paddy so that they will buy more rice seed from our group. We will continue to work with all other rice seed producer groups outside the districts to disseminate about our group's rice seed. This can be done in cooperation with village-commune authority, district agriculture office and other involved organizations or stakeholders including rice millers who are able to help to disseminate about our group's rice seed.

Project Description

We know that the needs of quality milled rice from the local consumers and abroad especially exporting markets but our farmers does not produce enough quality paddy to meet these markets yet. Most farmers sell their quality paddy on individual base, not collectively selling in bulk so that they are able to negotiate with the collectors for a better price. Cooperating with local authority, district agriculture office and development organizations, we plan to strengthen our existing producer groups to adopt new techniques in their productions especially direct seed planting practices. The techniques will be provided to the farmer groups through trainings or study trips. The strengthening activities include group management, increasing cooperation between group members for negotiating with collectors and rice millers, using fair weight scale, and collectively selling the paddy so that it would be easy for transportation. Additionally, we will collaborate with other producer groups to create a network inside and outside the district to exchange experiences, study trips on production practices, and access to pure rice seed as well as market information. Through this networking, we are able to know more and negotiate with the rice collectors, and increase opportunities to learn more about the cooperation and management of the rice producer groups

Project Description

Most farmers raise the pig on habitual base that the pigs raised face fatal diseases. The farmers sell the swine individually and nonsequentially, making the selling price low. Therefore, we, the pig farmers, proposed this project in order to foster and promote the technique-based swine production (sow and fattening pig productions), which gives quick return and more profit, in cooperation with development organizations and input (animal feed) supply companies so that we can access to new production techniques especially the techniques of disease prevention and treatment, and feed ingredient. Besides these, we will work together to strengthen our existing producer groups so that it will be easy for us to share practical experiences to sort out our necessary challenges, for example treatment of unknown diseases, and discuss with the group member for negotiating with buyers and using fair weight when selling. Moreover, to regularly supply to the market particularly local slaughterhouse, we will collaborate to create a network with support from village-commune-and-district authority, involved line offices and other relevant organizations.

Project Description

Nowadays, most chicken farmers are cautious in applying techniques for chicken production though they were trained while some others do not clearly know the techniques. Such productions will contact diseases and have high fatal rate, losing the money and unable to supply the market adequately. On the other hand, the chicken sale is occurred on individual base and without collective bargaining, which the buyers are able to lower the price and cheat at weight scale. We proposed this project in order to create new chicken producer groups and get capacity building for the existing ones. With this capacity building, we are able to plan our productions and receive technical trainings, which quicken the return, and sell on regular aggregate base that is possible for price negotiation with the buyers. Moreover, we will cooperate with community-based organizations, district office of agriculture and input (feed, vaccine, medicine) supply companies or visit successful farm to get new proper practical techniques that reduce death rate and diseases. We will also cooperate with OPED Angkor Chum and district authority to get technical trainings and disseminate the proper production techniques to other farmers.

Project Description

Currently, the vegetable sold in Angkor Chum is from Puok district where the vegetable is imported from neighboring countries. There is less vegetable producers who know about nursery and care. The growers produce vegetable for family consumption and sell less. There are many people needing local vegetable but the producers and collectors/traders do not work together to assure an appropriate price and regularly supply to the market. Thus, we proposed this project to create a network of vegetable growers to learn techniques of nursery and management through technical trainings in cooperation with input (seed, fertilizer, pesticide) supply company or through visiting successful farm and cooperative/community to learn production planning in cooperation with relevant organizations and buyers so that there is a negation for a higher price for the local product than the imported one and regular supply to Chhar Chhuk market.

Project Description

Project Description						
<p>We have learnt that this project was already piloted in three communes (Kouk Doung, Noukor Peas, and Doun Peng) to give an opportunity of increasing family income to the IDPoor households who are active and joined the technical trainings from different development projects. We want to continue and expand this project to other communes who are interested in enabling the poor to create a micro business that they have technical knowledge. There will be experience exchanges of success and failure of cooperation and market information access with other stakeholders so that the poor can learn and better their business. To succeed in implementing this project, commune authority will work with district-and-province authority in order to access to funding while the village chief disseminates the project concept and recruits the interested IDPoor households. Additionally, the commune will cooperate will cooperate with local successful farmers to technically support and give market information to the poor who joined the project.</p>						

Angkor Chum economic development concept paper was updated on 08 December 2015 in a workshop participated by the stakeholders from private, public sectors and civil society especially all initiators of the above-mentioned projects. There are 5 initiators of previously proposed projects and 27 of new ones taking part in the concept design, facilitated by OPED Angkor Chum, district core group partners and advisor of Regional Development Programm III (RED III), Siem Reap.

This concept papers consists of all different projects proposed by 32 representatives of the active and motivated stakeholders from three sectors as mentioned above. After compiled and firstly drafted with consultation from 47 stakeholders, there was a second meeting to discuss more detail on the projects, revise the strategies, vision and finally approve on 05 February 2016.

This local economic development concept paper is checked by board of district governors on 14 March 2016 and acknowledged by district councils in 22nd regular meeting on 16 March 2016 with 12 votes out of 15 votes.
