Regional Development Concept of Varin District

1. Introduction

In August 2008, district core group facilitated first workshop on the roles of public, private sectors and civil society in local economic development and as the results, there are many quick-win requests. This workshop was participated by three groups of stakeholders from public (district authority, commune council, and line offices), private sectors (farmers, businessperson, collector, rice miller...) and civil society (association, farmer groups...). In the process of local economic development with promoting voluntary cooperation amongst the stakeholders of the three sectors, we have organized many income-generated activities that the people can access to increase their income such as rice agreement between buyer and seller, fair weigh scale use, re-activation and new creation of farmers groups (saving groups, producer groups), the farmer accessed to trainings and adopted new techniques in rice, animal, and fish production ... etc. The motivated stakeholders from three sectors proposed different projects that they are the implementers in order to benefit them, community as well as the district. Those projects are compiled in a document named "Varin District Economic Development Concept".

The development of this concept paper is aimed at having a common orientation amongst all stakeholders in the district to promote local economic development, complementing the district development plan, attracting attention of outsiders, informing and involving the investors.

Since 2011 till now, the Varin District Economic Development Concept has been compiled for 5 years in 2014. Green Economic Development Community of Varin was established to coordinate all projects written in this concept paper. Most of the projects have been implemented actively and successful with technical supports facilitated by Green Economic Development Community of Varin. These supports deilvered by Center for Study and Development in Agriculture (CEDAC), Agrotech Vita (Kou Khmer), Bayon Heritage Holding Groups, East-West Seed, Medivet (animal feeds/medicines supplier), Lyhong Choy (Fish feeds/medicine supplier), BKP(animal feeds/medicines supplier), Angkor Green (agricultural input suppliers), rice millers, Sansom Veasna Center, expat specialists in bamboo, ADDA, and financial and technical supports from Regional Economic Development (RED III), Siem Reap. The project imitators stop some projects which had no activities. At the end of 2015, we started to update this concept paper by deleting some unimplemented projects and add some new ones proposed by the active initiators.

2. Varin's Strengths

- Natural resources such as forest (Bamboo, Rattan-La Pak-Pdao-Dam Dorng, Forest Vegetable) mountain, wild life, moderate-fertile soil, water source, natural fingerling, grass field for animal production
- · The natural landscapes and historical sites which can be served as tourist sites
- Favorable places for organic production
- The resident prefers agricultural production (rice, vegetable, fruit and animal)
- The resident is interested in working as a group, association, and community (e.g community forestry protects 10,000 hectares of forest and fingerling conservation)
- District is located in the centre of the big markets (in O'Dameanchey, Ou Smarch and Chaem Checkpoints, Srei Snorm, Chong Kal, Kralanh, Puok and Siem Reap)
- Transportation roads connecting to the big markets, making a good transportation
- The residents changed old habits and have started to adopt new techniques
- Willingly participate in the development activities in the district

3. Challenges

- The district's producers lack of technical skills in agriculture, animal production, product promotion, and processing
- The investor is less interested in district's potentials
- · Lack of irrigation system and drought
- · Lack of cooperation for collective sale

4. Vision

Within 3 years the living condition and income of our Varin's residents particularly the ID poor will be simultaneously improved through digesting the technical skills, experiences, and cooperation amongst all stakeholder groups with the sustainability assured for the natural resources and environment.

In Varin district, most of the farmers have not used pure rice seed yet even the pure rice seed can increases the yield and produce good paddy, which is easy for sale. Our rice seed production is not properly implemented yet and our seed sale promotion is still less. Therefore, we raise this project in order to strengthen and increase group member for more production and broadly promote our rice seed in the district as well as cooperate with other rice seed producer groups in other districts. To successfuly implement the project, we plan to strengthen the member management, rice production techniques as well as visiting the farmer/group who is successul in both technical practices and sale. Additionally, we aim at expanding the member, motivating to have cooperation amongst members, jont sale with other members and having internal quality control, having bag for packaging the seed with logo and phone number of the producer member to assure the quality for the buyers. The cooperations with authority, district agricultural office, NGOs/IOs can make the project successful as it is easy to sell and transport the seed. Moreover, we will cooperate amongst rice seed producer groups inside and outside the district to exchange experiences—technical practices, market information, price, negotiation, connect to more collectors as well as creating learning opportunities to understand clearly about cooperation. We plan to construct dam, canal,

watergate to increase yield for our farmer gorups.

Project Description

Nowadays, the people in our country and abroad demand high quality milled rice for consumption and this quality rice is being exported a lot but the farmers' production is not adequate for the market demand. Most of the paddy producer is still selling on individual base without cooperation or negotiating with the collector, which are the causes of lowering the price. In cooperation with authority, district agricultural office, NGOs/IOs present in the district, government rice production and export promotion policy, our project will strengthen and increase group member to produce more and more quality paddy. The strengthening focuses on planning and management as well as increasing new group members to cooperate with each other and for collective sale in negotiating with the collectors or rice millers in order to easily sell and transport the paddy. We concentrate especially on some varieties amongst ten varieties recommended by the government. Moreover, we will cooperate with other groups inside and outside the district to exchange practical experience--technical practices, market information, price, negotiation, connect to more collectors as well as creating learning opportunities to understand clearly about cooperation and better group management.

Project Description

From time to time, most of the farmers raise pig on habit-base techniques without having techniques. That causes fatal diseases, slow growth and sell on individual and irregular bases with low price. Therefore, we, the pig raisers, propose this project to promote and disseminate pig production (fattening pig and sow) on technique base, which quickly generates profits, in cooperation with development organizations and input (feed & medicine) companies and village vet to access to new techniques especially prevention, treatment and feed making. Besides these, we will cooperate with each other to strengthen the existing groups to promote new raisers who are interested in understanding the benefits of cooperation as groups or creating new groups. That is to easily exchange the experiences, deal with the immediate challenges in the group such as unusual diseases and discuss each other to negotiate for the price and fair weight scale with buyer in recognition and supported by the authority (village, commune, and district) and district agricultural office regarding fair weigh scale. Furthermore, the cooperation amongst the groups to assure regular fattening pigs tot the slaughterhouse in the district.

Currently, some chicken producer groups in Varin do well in their production and sell a number of chickens to other farmers in the district and supply less outside the district. More and more farmers know how to select good breed which is the important factor to increase yield and price. We proposed this project in order to strengthen technical capacity for the group members who have already practiced technically so that they can have return from their production quickly and expand production through enlarging the space of the chicken house, cooperating with input (feed, medicine) companies and district agricultural office. Besides these, we will increase group members, motivate them to contact each other to share market information, motivate to learn how to negotiate and jointly sell by using fair weight scale, and reduce sale in quantities without scale. Moreover, we need to disseminate good production practices to other chicken producers through sharing successful experiences including technical practices, market information, and continuing cooperation amongst all chicken producer groups in Varin as well as the collectors in order to promote the sale of our local chicken broadly (3 times a year). The project can be run smoothly in cooperation with authority (village, commune, and district) and district office of agriculture to prevent or take action against the collectors who use unfair weight scale.

Project Description

These days, the demand of beef in Varin is gradually increasing while the cattle production is still on habit base which could not supply adequately. The farmers want to change their habit-based production i.e. freeing the cattle to better manage, providing regular feed and maintaining hygiene, which make cattle healthy and give more returns in term of more newborns with better price. We proposed this project in order to create cattle producer groups so that the groups can cooperate with each others to access better new production techniques such as how to select good breed, good grass variety making cattle grow fast, how to manage, prevention and treament of diseases..etc. Moreover, we will increase group members and train them on how to connect each other to know market information, learn how to negotiate and sell jointly. Further, we will diseminate to other cattle producers in our district so that they change habit-based production practices to new techniqeu pratices. Through cooperation with authority (village, commune, and district), we can better collaborate with catle collectors and slaughterhouse.

Project Description

Varin a romote district from Siem Reap city, where most of the farmers grow vegetbale for family conumption and have less vegetable for sale. Thus, the vegetable sold in Varin is mainly broght from Puok, and Siem Reap town where some vegetables are imported from nearby districts/provinces and some others are imported from neighboring countries. Having seen more and more demand of vegetables and opportunities to make more income, our farmer groups plan to group the vegetable growers who produce the vegetables adpated to the climate, water, soil conditions and met the demands of Sre Nouy and Anlong Veng markets. We proposed this project in order to strengthen our vegtable grower groups as well as deminate the production to other farmers to grow more and more so that regular yearround supply of vegetables to these two markets are assured. To achieve the project, our farmer groups will share techniacl experieces via study trip and sharing meeting, define regular production planning and cooperate with input (fertilizer, seed, pesticide) supply companies, NGOs/los and district office of agriculture. Moreover, we will create good connection with collectors to know the market demand before production and discuss with them about quality and price of the vegetable. Then we will mobilize other farmers to join and grow the vegetable as well.

This year 2015 Varin's farmers are interested in planting pumpkin to sell to local and exporting markets but the farmers do have the techniques for production, management, fertilizer application and pesticide use. We proposed this project in order to expand pumpkin production with technical base to get high yield and to share good experience to other farmers in cooperation with community based organization, input (seed, pesticide, fertilizer) supply company, district office of agriculture and other relevant organizations. We will discuss with collectors to know types of seed, quantity and price on the market. Grouping the producers will be easy to exchange necessary experience to make this production successful and assure regular supply to the market.

Changkran Rouy Mountain covers more than 9000 hectares of forest land, various animal species, Peuy water fall,

Project Description

wide rock field and different plant species which can be used as traditional herbals and home plants. In 2015 Changkran Rouy forestry community is registered and elected the committees facilitated by Mlop Baitang. The community arranges ranker groups to work 2-4 times per month and demarcates 25 posts for community boundary. Nowadays, the community gets legal support from commune to provincial levels and forestry administration construct 3 paths to the community, 3 guarding points, and prepares the resort of Changkran Rouy water fall. After having cooperated with Sansom Veasna organization, the community is testing feeding so that the animals get used to and come to the feed. To see the animal coming to the feed, each tourist needs to pay 10USD to the community. Seeing this potential, the community committee proposed this eco-tourism project with planning to set up 5 guarding points (1. At the entrance, 2. On the mountain near monk hermitage where there later will be a pagoda 3. At the water fall 4. At Rouhal/Dantouk 5. Changkran Rouy rock field) where each guarding point has homestays, huts at each touristic site for the visitors to have food, water closet, and sign boards to other sites on the mountain. The community committee and some members start to clear and clean the path to the water fall so that the local people can visit gradually. Sansom Veasna organization has support in trainings the member on how to greet, setup camping and cook the food for the visitors. Another opportunity is the ongoing construction of a gravel road from Outeay village to Baydot village, which increases accessibility of more and more local visitors. With the recent support from provincial authority, the community is recommended to seek for support from proivincial department/ministry of tourism on eco-tourism development. The challenges in the community are that some members seldomly involve and people of nearby districts always illegaly log or hunt (disturbing/frigthening the animals being tested feeding) as there are many entrances (from Sre Nouy coomune, Angkor Thom, Angkor Chum and Banteay Srei Districts) made difficulties to walk guard. To run and achieve the project objective, the community committee requests supports from NGOs/IOs, relevant provincial department/ministry as well as authority and competence at all levels to build capacity to the community member so that they can organize, manage more effectively and sustainably protect the community forest, and promote to the national and international tourists. Additionally, it can disseminate to non-community members to understand and stop deforestation and kill the wild lives.

Varin is one of the district with wild bamboo situated along the river, in the forest, in some rice field and in the community forest. It is the potential for Varin's farmers as there is demand of bamboo for different utilities such as construction materials, handicraft products and weaving materials. No proper management and technical extracion make the farmers able to benefit less from the existing bamboo, low quality and price. Our farmers proposed this project in order to create a community to take actions for management and projection of the existing bamboo with supports from local authority and forestry administration such as changing people habits of invading the forest land, stopping burning bamboo forest, and having proper extraction of bamboo and shoots. Additionally, There are some areas in the community forest, where we can re-plant the bamboo such as Changran Roy community forestry which has about 100 hectares of thatching grass field where bamboo plants can be suitably grown. Along the water streams, there are free land where there is not suitable for the crops but appropriate for bamboo planting which can prevent erosion and have economic benefits as it is demanded by the local market. Regarding the existing forestry communities, they can start to manage and extract the bamboo to supply to the market in the comming year 2016.

To promote the bamboo plantation with quality and quantity, the project need to improve and increase the varieties at the existing bamboo nursery and share good practical experience to other local farmers so that they can plant with time saving and earn inocme from bamboo plantation.

The trainings on processing techniques for our group were delivered by Green Economic Development Community of Varin in cooperation with RED III. After successful testing, we will promote other processing groups to expand production in order to broadly supply the market.

Our famer groups signed a contract farming No. 00290 with Cambodia Nathan Trading Co., Ltd. Now some other farmers are interested in growing this crop because it returns for long term and no need to grow every year. It is easy to harvest and has existing export market handled by the company contracted buying from the farmers at an appropriate price. However, this crop is new, needed to grow in the organic environment, proper management, fertilizer use and organic pesticide. Also, we do not know clearly about the crop development and challenges such as diseases and the collection of company. Therefore, our farmers raised this project in order to work with authority (village, commune, and district) and expert to follow up the company as our farmers have not harvested yet, worrying us of how the company will collect. Moreover, we need the technical support from civil society organizations in terms of technical on production, and proper use of organic fertilizer and pesticide. In the future, the contract farming works as planned, we will increase producer groups as this crop is another income generated sources for the family.

Project Description

Nowaday, cassava is dominating on the export market of agricultural product to neighboring countries yearround. The market demand of cassava depends on the collectors and harvest time when sometime the market needs fresh cassava and other time needs dried one. Cassava is an important source for our farmers' income in Varin district but majority of cassava farmers do not learn techniques for production. They learn from their own practices or others' experiences and bought stems to grow all seasons but sometime there are diseases or the stems did not germinate well, making problems for the soil and low yield. This project aims at creating producer groups and connecting each other as a network so that it is easy to exhange experiences on production techniques, proper use of fertilizer and pesticide as well as cassava diseases prevention and treatment. Moreover, it is aimed at collective sale in large amount and contacting the collector to negotiate for an apropriate price and use fair weight scale. Further, the creation of this network is to facilitate the cooperation or support from the local authority or microfinance institues and techical supports in terms of chemical fertilizer and pesticide use or other any support from civil organizations as well as private input supply companies.

From time to time, the people in the community and Baydot village lack of water for daily lives both human and animal, and the people cannot grow any crop as particularly in dry season there is no water at all in the river or stream. As always, in the rainy season the people bring unsafe and unclean water for their family use from the stream about 1km far from the village. Surrounding the water streams, there are cassava field where chemical agricultural pesticides and fertilizer are used, polluting the environment including harvesting, cutting and drying. Facing the mentioned situation, the community committee and other important stakeholders initiated this project in order to access to clean and safe water that is not effect on public health, saving time of people for running and increasing other livelihood activities for their families. This project will construct a dam about 50 meters, 4 meter base and connect big pipelines laying down at least 2 kilometers across 3 community guarding points (1. At the entrance, 2. On the mountaintop, and 3. Near the water fall). The community is the management and contributors to other people with an appropriate price. Most of the people are interested in accessing the water with contribution paid to the community following an appropriate price in order to support the community to earn income and account it in the future. This project idea can be achieve when there are cooperation and support from authorities (provincial, district, commune, village and forestry administration). Additionally, we need to cooperate with other people outside the community so that they learn about protection and maintenance this water system for long term accessibility.

We have already learnt that this project was piloted in two communes (Srae Nouy and Savy Sor) to offer opportunities to increase income to the IDPoor households who are industrious and used to learn production techniques delivered by the program or other NGOs/IOs. After district council and commune council joined a study trip, they requested continuing this project in order to support the poor in their communes. As the commune council, we are interested in this proposed project as it is enabling the poor to create a micro business based on their technical skill and successful and failure experiences, cooperation and market information access from other stakeholders in order to further progress their business. This project cannot be successful unless village authority disseminates information about this project and selects the interested IDPoor household while commune council cooperates with district and provincial authorities to get the financial support and trainings for the poor so that they learn the techniques, reducing more risks.
